A manager is not considered approved until he or she is approved by both the Local Licensing Authority (i.e., the Board of Selectmen) and the Alcoholic Beverages Control Commission (ABCC).

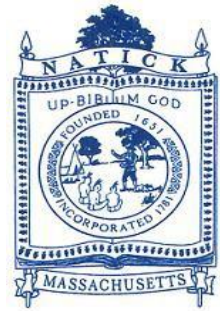
