On February 10th, 2018 the Natick Rotary Club is holding an event to help raise money to benefit the Natick Rotary Charitable Corporation's Opioid Fund. The event is being held at the Natick Community/Senior Center from 6-9 p. m. We were hoping to have a cash bar for the event offering beer and wine for purchase during the event. We are anticipating between 125 and 150 people for this event and have spoken with Lt.
