

Please be advised that we contacted by the MBTA / Keolis this morning and they would like the stair replacement work to occur this Saturday (July 21<sup>st</sup>).


Schedule of operations would be the same as the original planned date.

I did. He is looking for this Saturday, apparently at the request of the MBTA. Melissa is due in shortly -- I will check with her to see what she wants to do.


