Hello Bryan,

Following up on our conversation, the attached certificate of insurance for Ambient Temperature Corp. provides coverage that fulfills the Town of Natick's insurance requirements, including the \$1,000,000 Employers' Liability requirements. Even though the certificate lists the Employers' Liability limit at \$500,000, Ambient actually has \$10,500,000 worth of Employers' Liability coverage. This is so because the \$10,000,000 Umbrella on the certificate rides/stands over the Employers' Liability coverage. So we add the \$10M Umbrella to the \$500K Employers' Liability to arrive at a \$10,500,000 Employers' Liability limit.
