A. COVID-19 Virus

- Public health update: Director of Dept. of Health, James White, gave his update on COVID in Middlesex County including deaths, positive results and those in quarantine. Our public health nurse will assist beyond her retirement. We have a Hotline with people taking calls for any resources the public may need: 508-647-6540.
- Update of relief legislation: Karis North, Town Counsel: Ms. North spoke about provisions relating to Town Meeting through the state of the emergency period. On premise licenses for alcohol may soon be able to provide take out alcohol with very specific wording. Ms. North will have additional information after Wednesday, April 1, 2020.
- 3. Town update of services and events: Ms. Malone: All of our buildings remain closed to the public. For the South Main Street project, the Eversource utility poles will begin to be moved. The Recycling Center remains open.

Summer camps are still being evaluated. Community Gardens and golf course are closed. The date of the Marathon was changed to 9/14/2020. Natick Days will need to be rescheduled. The Town municipal building remains closed. We are using the mail slot at the front of the building at Town Hall for payment of taxes.

Libraries are assisting with our census and other enrichment opportunities. All parks are closed, including the dog park.
