**RE:** Draft 2020 Open Space & Recreation Plan Update – ready for review

Meeting Date: June 15, 2020

The Open Space Advisory Committee and Community & Economic Development have been working on updating the Town of Natick's Open Space & Recreation Plan (OSRP). The OSRP is a crucial guiding document in the community that inventories the Town's open spaces and recreational amenities, tracks accomplishments made since the last OSRP Update, and establishes an Action Plan of goals, objectives, and projects.

The OSRP is required to be updated every seven years in order for the Town to be eligible for related State grants and funding. Natick's 2012 OSRP expired in June 2019. Over the past few months, we have been working hard on the 2020 OSRP Update. Most of the 2012 OSRP is still valid today. Areas that have been updated include:

- population demographics,
- inventory of lands (new lands have been protected), and
- the Action Plan (projects have been completed, new projects have been added).

The first phase of outreach surrounding the 2020 OSRP Update was conducted in April/May. Outreach included a variety of methods in order to obtain feedback on the open space and recreation environment in Natick and the Draft Action Plan. Public input received from that phase has been incorporated into the Draft 2020 OSRP.

The Draft 2020 OSRP is now released for public review and comment through June 30<sup>th</sup>. We would like to request the Board of Selectmen to provide comments on the draft plan and additionally provide a letter of review/endorsement.

We will be in attendance at the June 15<sup>th</sup> Board of Selectmen meeting to provide more information and next steps on this process.
