A. Boston Marathon 2020 Update

The Boston Athletic Association (B.A.A.) has announced that the 124th Boston Marathon will be held as a virtual event, following Boston Mayor Martin Walsh's cancellation of the marathon as a mass participation road running event due to the COVID-19 pandemic. The virtual Boston Marathon will be complemented by a series of virtual events throughout the second week of September.

Natick Common Trees:

Arthur Goodhind, Tree Warden, submitted a letter regarding Natick Common trees: "Natick has likely experienced an infestation of an invasive insect pest known as the Emerald Ash Borer (EAB). The Emerald Ash Borer is an invasive insect pest that was accidently introduced into the United States in 2002 and aggressively attacks and ultimately kills Ash trees as well as some other select tree species. On the Natick Town Common there are ten Ash trees, nine of which have a confirmed infestation, with one having a probable infestation. The damage caused by the EAB to these trees is irreversible and the trees are experiencing rapid decline. Unfortunately, these ten trees will need to be removed due to the rapid decline and the presence of this invasive insect pest."

Natick Mass Drive Through:

On Thursday, July 2, 2020 at 10:00am, the Natick/Sherborn Sewing Support Group will be sponsoring a Mask Drive Thru for Natick Residents. This is a FREE event for Natick residents. This will take place at Natick High School and the entrance is by the Preschool playground. The masks are free while supplies last. A very big thank you to the Natick/Sherborn Sewing Support Group. Director Department of Public Health, James White: Natick COVID cases: 14 probable cases; 1 positive. 463 cases since March 1, 2020 in Natick. No deaths in Massachusetts as of yesterday. There is still a positive trend here. Citizens should continue to be very vigilant.

Chief James Hicks continues preparations for reopening on the Town and School side. The Chief noted that he had two large PPE orders come in today. Chief Hicks also noted that he is very comfortable with 60-90 days' worth of equipment as we move toward reopening.
