The following funds are provided to the Town of Natick by and on behalf of sponsors of the Cochituate Rail Trail. Thank you for accepting and acknowledging these donations at your meeting of January 13, 2021.

Pursuant to the Board's vote on December 2, 2020, it is our understanding that these funds will be deposited into an account reserved for maintenance and enhancements of the CRT. A suggested motion is:

"Move to accept and acknowledge the donations listed in the January 12, 2021 memorandum to the Natick Select Board from the Friends of Natick Trails, said funds to be reserved for Cochituate Rail Trail maintenance and enhancements to help the Town maintain the CRT in a state of good condition consistent with the intention of these donations."
