# SELECT BOARD UPDATES

A. COVID-19 We have seen an uptick in COVID.

James Errickson, Deputy Town Administrator, Operations: We continue to monitor our buildings. As the weather gets colder we may want to consider how we modify our interaction with staff/citizens. The Bacon Free library is doing appointment only approach. The Cole Center will also be opening up. The Senior Center will be planning an appointment only opening in early October. This will be very limited programming.

B. DPW Bulky Waste Collections Program - Update

A full memo is attached to this agenda on Bulky Waste Collections. On August 3, 2020, bulky waste pickup was resumed on Mondays. We are now booked through the month of October. We have temporarily suspended taking applications because we are now fully booked. It costs us about \$115 per collection. There are also local businesses that do this service other than the Town. Residents can bring bulky metal items to the recycle center for free.

Ms. Malone, Town Administrator: We are looking for short term borrowing which would leave our capital stabilization largely intact. The capital stabilization fund has less than 5m dollars in it at this time. We have typically put the local receipts which are between 1.2 and 1.4m dollars and appropriated that into the capital stabilization along with some free cash. We are still looking at what those financing terms would look like. We would still need to pay that money back.
