## **SELECT BOARD UPDATES**

#### A. COVID-19

James White: There has been an uptick in the Mass COVID numbers. A 1% increase in the number of positive tests. Metrics in hospitalizations have gone up (400 hospitalized). The numbers haven't been this way since July. There has been an uptick in Middlesex as well, however Natick remains in the green (20 positive cases with 3000 tests

conducted).

B. Dr. Anna Nolin, Superintendent of Schools: Natick High School is now closed for 2 weeks due to a non-compliance issue. We cannot control how people behave outside of school and then they return to school. Because we could not get truthful answers, we decided to close Natick High School for two weeks.

#### 1. <u>DISCUSSION AND DECISION</u>

- A. Water and Sewer Abatement Appeals
  - 1. William Kourtis/LILI Realty Trust

Mr. Kourtis of LILI Realty Trust appeared for a water/sewer abatement hearing before the Select Board this evening. In order to more fully understand all the details of this abatement, Mr. Errickson will be checking all the numbers and rates and will get back to the Board. Mr. Kourtis will appear at a subsequent hearing for a formal decision before this Board.

B. Consider establishing a Town Government Study Committee

The full memo from Frank Foss, Town Moderator and Ms. Salamoff, Board Member, of the Proposed Town Government Study Committee is attached to this agenda for this evening's discussion. Highlights from the memoranda are below:

At this time in our history, it seems prudent to evaluate the current structure of our town government and consider if there are more immediate changes that would create more efficiencies in the operation of our government as well as create better citizen access and ability to participate in their town government.

Should there be term limits for elected or appointed Boards, Committees or Commissions? Should Natick consider changing the overall structure of its government?

We propose the Select Board appoint a 9-member Town Government Study Committee to be composed of a present or past Select Board member, the Town of Natick Finance Director or designee, the Town Moderator and 6 citizens at large. At least two of the at large appointees should have served as a Town Meeting member for three years. The study committee shall provide a preliminary report to the Select Board within 6 months of being established. The report should include status of work and a plan to provide recommendations to the Select Board by 1-15-2022. Municipal counsel or consultant should be engaged to work with the Town Government Study Committee.
