The Town of Natick and Green International Affiliates, Inc. ("Green"), 239 Littleton Road, Suite 3, Westford, MA 01886 are parties to a contract, dated January 2020, for construction engineering/contract administration services for the South Main Street Construction Project.

As brought forth by the Town Engineer, the project has necessitated the performance of certain additional construction administration services, as outlined in Attachment A-2 to the attached First Amendment to the Contract.

State statute exempts the procurement of these types of additional construction administration services from the Uniform Procurement Act, M.G.L. c. 30B. See M.G.L. c. 30B, §1(b) (32A), which exempts the services of architects, engineers, and related professionals. (Parenthetically, the Designer Selection Law, M.G.L. c. 7C, §§44 *et seq.*, does not apply, since no vertical structure is implicated.) Essentially, therefore, there is no statutorily-prescribed procurement process that would govern.

Green is a responsible and responsive firm and has offered what DPW considers to be a reasonable sum for the purposes. It has also served as the engineering firm for design, bidding, and construction administration of the project to date.

We respectfully request that Natick Select Board award Green, the attached First Amendment, in the form of the attached, to perform the services outlined in Attachment A-1 to the Contract, as amended by Attachment A-2, for the hourly rates specified therein. The total present price cap, without further authorization, will be \$334,383.00

The previous contract cap has been \$264,487.00.

The funding to cover this comes from the following sources:

This First Amendment to Contract for Construction/Engineering Services - South Main Street Project (hereinafter "the First Amendment") is made as of this tenth day of March, 2021, by and between the Town of Natick, Massachusetts, with an address of Natick Town Hall, 13 East Central Street, Natick, MA 01760, acting by the Natick Select Board (hereinafter the "Town of Natick," the "Town," or the "Owner"), and Green International Affiliates, Inc., a corporation organized under the laws of the Commonwealth of Massachusetts, with a principal office located at 239 Littleton Road, Suite 3, Westford, MA 01886 (hereinafter the "Contractor").

WHEREAS, the Town and the Contractor (collectively the "Parties") are parties to a contract entitled "Contract for Construction/Engineering Services - South Main Street Project" (hereinafter the "Contract") that was made as of January 21, 2020; and

WHEREAS, the Parties mutually desire that additional construction administration services be provided by the Contractor;

NOW, THEREFORE, the parties hereby amend the terms of the Contract as follows:

1. In Article 1, "Scope," strike the existing language, and replace with the following:

"In consideration of the obligations herein contained, the Contractor shall provide consulting engineering services for roadway improvements to South Main Street in the Town of Natick, as set forth in Attachment A-1 (to the Contract), which is attached to and incorporated herein by reference, and as amended by the 'Proposal for Additional Construction Administration Services' letter from the Contractor dated February 8, 2021, which is incorporated herein by reference and attached to the First Amendment as Attachment A-2. The parties hereto agree that such services are exempt, pursuant to M.G.L. c. 30B, §1(b)(32A), from the provisions of the Commonwealth of Massachusetts Uniform Procurement Act (subsection 32A exempts services of architects, engineers, and related professionals)."

2. In Article 5, "Payment," strike the existing language of the second paragraph and replace with the following:

"This Contract is a time and materials contract and the Contractor shall be paid a 'fee' and expenses. The fee shall be based on actual hours worked at the hourly billing rates provided in Attachments A-1 and A-2. Expenses associated with the Contractor's work shall be paid by the Town. The total not-to-exceed amount of the Contract is three hundred thirty-four thousand three hundred eighty-three dollars and zero cents (\$334,383.00), inclusive of all labor and expenses."

3. Also in Article 5, "Payment," strike the existing language of the sixth paragraph and replace with the following:

"Should it be necessary for the Contractor to engage the services of a specialized contractor or companies other than those originally proposed in Attachments A-1 and A-2, the Contractor shall take such measures only with the Town's prior written approval. Charges for such services, with no mark-up, shall be billed directly to the Town unless otherwise agreed upon by the parties."

4. Except as provided herein, all other provisions of the Contract shall remain in full force and effect.
5. This First Amendment to Contract for Construction/Engineering Services - South Main Street Project is executed as a sealed instrument.

Dear Mr. McDowell:

Green International Affiliates, Inc. (Green) is pleased to provide this proposal to provide additional Construction Administration Services for the above referenced project related to providing additional services for preparing easement plans and legal descriptions, design services for the treatment of the proposed slope between Station 33+50 to Station 36+00 and additional construction phase support as described in more detail below. We have prepared the following Scope of Services.

***Scope of Services******Task 1 - Additional Construction Administration Services***

Based on our understanding, the construction of the project will be completed by July of 2021. The following table summarizes the number of reviews or meetings we budgeted for in our approved Scope of Services, the actual work performed to date and the additional scope anticipated to complete the construction oversight of the project.

We are requesting additional scope and budget to perform the additional reviews, RFI's and meeting attendance noted above. In addition, we are requesting additional budget for the additional effort described below.

**Task 1.1** – Additional budget is required for the increased effort we have expended in administering the project overall including the increased effort needed to coordinate with the Contractor's Project Manager, field personnel and the Town. This additional effort has been required, in part, due to drainage design revisions necessitated by changes in field conditions; changes to the wall designs requested by the Town at #170 and #166 South Main Street; additional research and evaluations of lot curb per the property owner and Town's request for #166 South Main Street; changes to the guardrail layout and evaluation of guardrail options at the southern project limits per the request of the Town and; future anticipated coordination efforts expected to be required to complete the project. Significant additional coordination effort with the Contractor's personnel has also been required that was not anticipated when the original budget was prepared. This additional effort includes providing responses to numerous emails and phone calls from the Contractor regarding disagreements in how work is to be paid for, performed or to address field issues that have been caused by the Contractor's operations.

**Task 1.2** - This scope of services is also to provide additional effort associated with the review of the Contractor's requisitions for payment (pay req) under Task 1.2. Our approved budget was based on prior project experience and typical review times and assumed each pay req would require on average 1.75 hours of review per pay req. The actual time spent on the review of each pay req varies but has averaged approximately six hours before the pay req can be approved for payment. The additional review time has been necessary due to the consistent errors and missing information that is found with each pay req provided by the Contractor. Even though the field personnel have agreed on items and quantities, the pay reqs have not reflected the agreed upon quantities in the field or agreed upon quantities are then modified by the Contractor when included on the pay req. This has required that we perform an in-depth review of multiple submissions of each pay req and our field personnel's daily reports and field notes to check each item and has also required frequent coordination and communication back and forth with the contractor to have the discrepancies addressed. This additional effort was not anticipated when we prepared our original budget.

### Task 2 - Heavey Slope

The Contract Plans proposed a 2:1 cut slope on the east side of South Main Street within the station ranges of 33+50 to Station 36+00 assuming that the Town will obtain the necessary easements for this work. This results in work beyond an existing sidewalk easement. The abutters at this location have not granted the Town permission to conduct the work required within their property and the Town has asked that Green evaluate a steeper slope to keep all the work within the existing sidewalk easement.

We will engage our subconsultant, Terracon Consultants, Inc. who will perform a site visit to observe soil/rock slope during construction and obtain bulk soil samples for soil laboratory testing. They will perform direct shear testing on two bulk soil samples in accordance with ASTM D3080 and perform a slope stability analyses using the computer program SLIDE. They will prepare slope stabilization recommendations and summarize in a letter report. All analyses and reporting will be performed under the direct supervision of a professional engineer registered in the Commonwealth of Massachusetts.

Based on the recommendation from our subconsultant, Green will prepare revised typical sections, plans and cross sections to reflect the revised slope design and submit to the Contractor. The revised plans will also include proposed shrubs and trees as requested by the Town to provide slope stabilization, screening to the Heavey Property and to provide a deterrent to prevent people on the sidewalk from trying to climb the slope. We will review the Contractor's change order costs for reasonableness and provide a recommendation to the

Town. We anticipate that we will review one construction submittal related to the recommended slope revisions such as slope reinforcement fabric.

Task 3 - Prepare Easement Plans and Legal Descriptions

We will develop the Easement Plans based on the existing layout lines. The plans will be prepared in accordance with 250 CMR 6.02. It is anticipated that the Town will prepare the legal descriptions of the parcels for their use in recording at the Registry of Deeds. The Town will be responsible for providing clear title to subject parcels prior to recording of easement plans and instruments of conveyance. The Town will also be responsible for all filing fees, preparation of legal documents and recording the plans at the Registry of Deeds.

The easement plans will include property lines, names of property owners and the locations of all bounds. We will show lengths and bearings of all lines and calculate areas. Green assumes five (5) sheets containing eight (8) permanent easement parcels will be required.

The following items are not included in this proposal but may be added as a separate agreement if required:

1. Preparation of Legal Descriptions Metes and Bounds
2. Easement Plan Peer Review
3. Stakeout of easement corners including installation of bounds, iron pins, etc

**FEE:**

The total estimated cost to provide the additional services described above is \$69,896 as shown on the attached work-hour estimate and fee schedule.

The fee is an estimate based on assumptions of the time required to complete the work. The actual work will be completed on a Time and Materials basis using the following rate structure. There is no mark-up on incurred expenses.

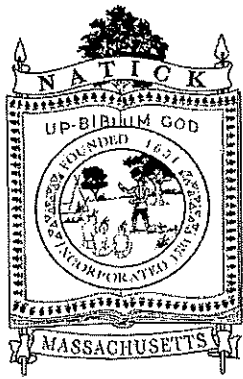

This Contract is made as of this twenty-first day of January, 2020, by and between the Town of Natick, Massachusetts, with an address of Natick Town Hall, 13 East Central Street, Natick, MA 01760, acting by the Natick Board of Selectmen (hereinafter the "Town of Natick," the "Town," or the "Owner"), and Green International Affiliates, Inc., a corporation organized under the laws of the Commonwealth of Massachusetts, with a principal office located at 239 Littleton Road, Suite 3, Westford, MA 01886 (hereinafter the "Contractor").

The words "he," "him" and "his" in this Contract, as far as they refer to the Contractor, shall so refer whether the Contractor is an individual, partnership or corporation. All prior contracts, if any exist between the Town and the Contractor, are hereby terminated and shall be of no force and effect.

1. Scope

In consideration of the obligations herein contained, the Contractor shall provide consulting engineering services for roadway improvements to South Main Street in the Town of Natick, as set forth in Attachment A-1, which is attached to and incorporated herein by reference. The parties hereto agree that such services are exempt, pursuant to M.G.L. c. 30B, §1(b) (32A), from the provisions of the Commonwealth of Massachusetts Uniform Procurement Act (subsection 32A exempts services of architects, engineers, and related professionals).

2. Standard of Care

The Contractor shall exercise due care and diligence in the rendering of all services under this Contract in accordance with the applicable professional standards in the Eastern Massachusetts area. The Contractor's services shall be performed as expeditiously as is consistent with such standards, with professional skill and care, and with the orderly progress of the work.

3. Term

The term of this Contract shall commence as of the date set forth in the first line of the first paragraph above and shall end two (2) years later. At the sole discretion of the Town of Natick, the term of this contract may be extended for an additional one (1)-year term.

4. Order of Priority of Contract Documents

In the event of any conflict among the Contract Documents, the Documents shall be construed according to the following priorities:

Highest Priority:	Amendments to Contract (if any)
Second Priority:	Contract.

5. Payment

In consideration for performance of the work in accordance with the requirements of this Contract, the Town shall pay the Contractor the prices set forth herein.

This Contract is a time and materials contract and the Contractor shall be paid a "fee" and expenses. Payment shall be made to the Contractor for work completed in accordance with this Contract. All requests for payment shall be submitted to the Town as an invoice and shall specify all services rendered.

Payment will be due thirty (30) days after receipt of the Contractor's invoice by the Town for services rendered in accordance with this Contract. The Town shall not make payments in advance.

If the Town objects to all or part of any invoice, the Town shall notify the Contractor in writing within two (2) weeks of the date of receipt of the invoice, and shall pay that portion of the invoice not in dispute within thirty (30) days after the date of receipt of the invoice.

Should it be necessary for the Contractor to engage the services of a specialized contractor or companies other than those originally proposed in Attachment A-1, the Contractor shall take such measures only with the Town's prior written approval. Charges for such services, with no mark-up, shall be billed directly to the Town unless otherwise agreed upon by the parties.

Payment of the amounts due under this Contract shall release the Town, Massachusetts and its officers, employees, boards, commissions, committees, agents and representatives, from any and all claims and liability in any way relating to this Contract or anything done in pursuance thereof.

No payment by the Town to the Contractor shall be deemed to be a waiver of any right of the Town under this Contract or ratification by the Town of any breach hereof by the Contractor.

6. Warranty

7. Compliance with Laws

The Contractor shall comply with all provisions of Federal, Massachusetts and Town of Natick law applicable to his work including, without limitation, statutes, by-laws, rules, regulations, orders and directives, as amended, and including, without limitation, the Williams-Steiger Occupational Safety and Health Act of 1970, as amended, and related regulations, as amended, in effect throughout the term of this Contract and any extension or renewal thereof. Without limitation, the Contractor shall comply with the provisions of Chapter 149, Section 26 to 27D of the Massachusetts General Laws, as amended, and the applicable minimum wage rates as determined by the Massachusetts Commissioner of Labor and Industries. This Contract shall be considered to include in their entirety all

terms respecting workers' compensation insurance and other terms required to be included in it by Chapter 152 of the Massachusetts General Laws, as amended, as though such terms were set forth in their entirety herein.

**8. Insurance**

The Contractor shall provide and maintain throughout the term of the Contract and any extension or renewal thereof the following insurance with companies that are authorized and licensed in the Commonwealth of Massachusetts to issue policies for the coverages and limits so required.

- a. Workers' Compensation Insurance as required by the laws of the Commonwealth of Massachusetts and employer's liability insurance in the amount of \$1,000,000/\$1,000,000/\$1,000,000.
- b. Commercial General Liability Insurance, \$1,000,000 each occurrence and \$2,000,000 aggregate limit. Commercial General Liability insurance shall include personal injury liability, broad form property damage liability, products/completed operations liability and broad form contractual liability.
- c. Automobile Liability Insurance, covering all leased, owned, non-owned, and hired vehicles - Combined single limit of \$1,000,000.
- d. Professional Liability Insurance, \$1,000,000 each occurrence/\$2,000,000 aggregate limit. If written on a claims-made basis, each such policy shall remain in effect for at least six (6) years following the termination of this Contract.
- e. Excess Liability Insurance, Umbrella Form - \$1,000,000 each occurrence and \$2,000,000 aggregate, which shall be following form, providing coverage over commercial general liability insurance, automobile liability insurance, and employer's liability under workers' compensation insurance.
- f. The Town shall be named as an additional insured on each such policy of Commercial General Liability Insurance, Excess Liability Insurance, Umbrella Form, and Automobile Liability Insurance.
- g. All certificates and policies shall contain the following provision:  
  
"Notwithstanding any other provision herein, should any of the above policies be cancelled or materially amended before the expiration date thereof, the issuing company will mail thirty (30) days prior written notice thereof to the named certificate holder and to the Natick Town Administrator, Natick Town Hall, 13 East Central Street, Natick, MA 01760 before such cancellation or amendment shall take place."
- h. Certificates evidencing such insurance in five (5) copies shall be furnished to the Town at the execution of this Agreement. Such certificates shall not merely name the types of policy provided, but shall specifically refer to this Agreement and shall state that such insurance is as required by this Agreement. shall make no claims against the Town or its officers for any injury to any of its officers or employees or for damage to its equipment arising out of work contemplated by the Agreement.

- i. The Contractor shall also be required to provide to the Town with its proof of insurance coverage endorsements or riders to the policies of commercial general liability insurance, automobile liability insurance, and excess liability insurance, umbrella form, which indicate that the Town is named as an additional insured on each such policy.
- j. No insurance shall be obtained from an insurer which:
  - (1) is not licensed to sell insurance in the Commonwealth of Massachusetts; or
  - (2) is not authorized to provide insurance as an excess or surplus lines insurer, and does not have a current Best's rating of A or better.
- k. Failure to provide and continue in force such insurance as aforesaid shall be deemed a material breach of this Contract and shall operate as an immediate termination thereof.

**9. Indemnification**

The Contractor shall compensate the Town for all damage to Town property of any nature arising out of the Contractor's work. To the fullest extent permitted by law, the Contractor shall indemnify, defend, and hold harmless the Town and all of its officers, employees, boards, commissions, committees, agents and representatives from and against all claims, causes of action, suits, costs, damages, and liability of any kind which arise out of the breach by the Contractor of its obligations under this Contract, or the act or omission of the Contractor, its subcontractors, or their officers, employees, agents and representatives or anyone directly or indirectly employed by them, or anyone for whose acts or omissions they may be liable, regarding the work to be performed by the Contractor under the Contract, or which arise out of the violation of any federal, Massachusetts or Town of Natick statute, by-law, rule, regulation, order or directive, or which relate to personal injury or property damage suffered by the Contractor or any of its officers or employees regarding the subject matter of this Contract. SCOPE OF SERVICES

The parties have agreed upon the following scope, where by Green shall provide Construction Administration and full-time Resident Engineer services for the above referenced project. Based on the parties' understanding, Green shall provide Construction Administration Services and a full-time Resident Engineer to oversee the construction for the subject project. Construction is anticipated to begin on or around April 20, 2020 and will be completed by August 28, 2021. It is estimated that there will be approximately 336 working days (16 months) of construction, 12 months of which will require a full-time Resident Engineer. The remaining time is assumed to be minor and incidental work for which a full-time Resident Engineer is not required or that will be covered by Town personnel. Green can provide full-time services for the duration of the work upon request and approved amendment of this Scope of Services.

Green will provide Construction Administration Services to oversee the overall progress of construction and our Resident Engineer, review and process payment requisitions, review shop drawing submittals, make periodic site visits to observe the ongoing work and address any issues and respond to Contractor Requests for Information (RFI).

The Resident Engineer Services will include daily construction observation services, daily monitoring of construction activities, overseeing the progress of work and verifying the use and quantity of materials for compliance with the Contract Documents.

Green proposes the following Scope Work and fee to provide Construction Administration Services and full-time Resident Engineer Services to the Town for the subject project:

**SCOPE OF WORK**

**Task 1 - Construction Administration Services**

***Task 1.1 – Overall Construction Coordination and Pre-Construction Meeting***

We (Green) anticipate that the duration of active work for which Construction Administration Services will be required is sixteen (16) months. We will attend a pre-construction meeting and prepare minutes. We will coordinate with the Town during the construction of the project and provide regular progress updates through the Resident Engineer. We will provide periodic site visits during the construction. We have budgeted thirty-two (32) trips to the Natick DPW offices or the site for meetings or site visits at an average length of 4-hours each, including travel time. This is about one meeting every two weeks of construction. We have estimated the budget for this task assuming that the Project Manager attends four (4) of the meetings, the Project Engineer attends eight (8) of the meetings and a Staff Engineer attends all of the meetings.

***Task 1.2 – Payment Requisition and Change Order Reviews***

We will review contractor requests for payment and change order submittals (if any). It is assumed that payment requisitions will be submitted by the Contractor monthly and that there will be up to sixteen (16) payment requisitions. It is assumed that no more than three (3) change orders will be submitted by the Contractor. We will review the change orders, if any, for reasonableness and coordinate with the Town and Contractor on any comments.

***Task 1.3 – Shop Drawing and Request for Information Review***

We will review contractor submittals and respond to contractor requests for information during construction. All submittals are anticipated to be electronic and are anticipated to include the review of the drainage related materials, pavement materials, subbase materials, guardrail items, concrete for sidewalks, stone masonry retaining wall layouts, signs and pavement markings. We will review clock diagrams submitted by the Contractor for the proposed 87 drainage structures. We anticipate up to fifty (50) construction submittals for roadway and drainage related items will be submitted. We assume that half of the submittals will require one resubmittal and re-review.

We will review contractor requests for information. We anticipate five (5) formal requests for information from the Contractor.

***Task 1.4 – Final Project Close-Out/Punchlist***

We will attend one (1) site walk with the Contractor and the Town to prepare a punchlist of outstanding items to be addressed. We will compile and submit copies of relevant construction documentation to the Town. We will attend one (1) additional Final Site Walk to review the punchlist and confirm that the items have been satisfactorily addressed.

***Task 1.5 – Review As-built Plans***

We will review the as-built plans prepared by the Contractor of the completed improvements for the project. The review will be limited to confirming the materials and locations of the improvements based on the field notes and marked-up plans of the on-site Resident Engineer. The review will not include confirming the elevations of the pavement, rims and inverts. Survey is not included in this task

**Task 2 - Resident Engineering Services**

Green will provide a Resident Engineer to the Town of Natick for the duration of the construction which is assumed to be 252 working days and 8 hours per day. The Resident Engineer will perform the following tasks:

- Perform construction observations and accept/reject materials, equipment and supplies delivered/installed in the work site;
- Prepare and maintain a construction "punchlist" of work to be completed or corrected by the Contractor;
- Maintain records for and attend meetings with representatives of the Town and the Contractor and other agencies having jurisdiction over the work;
- Maintain documentation, survey notes, and a set of marked-up prints of the completed construction;
- Review contract documents and approved shop drawings to identify and report degree of Contractor compliance with the contract documents;

The total estimated cost to provide Construction Phase Services and Resident Engineer Services is \$264,487, as broken down below and the attached man-hour estimate and fee schedule. Said amount shall not be exceeded without prior authorization from the Town and sufficient appropriation to fund such an expenditure.

**Task 1 - Construction Administration Services**

The total estimated cost to provide Construction Administration Services is \$92,737.00

The fee for Task 1 is an estimate based on assumptions of the time required to complete the work and estimated expenses including a \$7,000 allowance for materials testing. The actual work will be completed on a Time and Materials basis using the following rate structure. There is no mark-up on incurred expenses.
