Throughout my career, however, I developed multiple affiliations with civic and government entities in order to enhance support for grass roots project implementation that I was involved with, and these are highlighted on my resume.

I am keenly interested in efforts to promote healthy aging and support for older adults to engage with community activities, and be able to age in place in their own homes.
