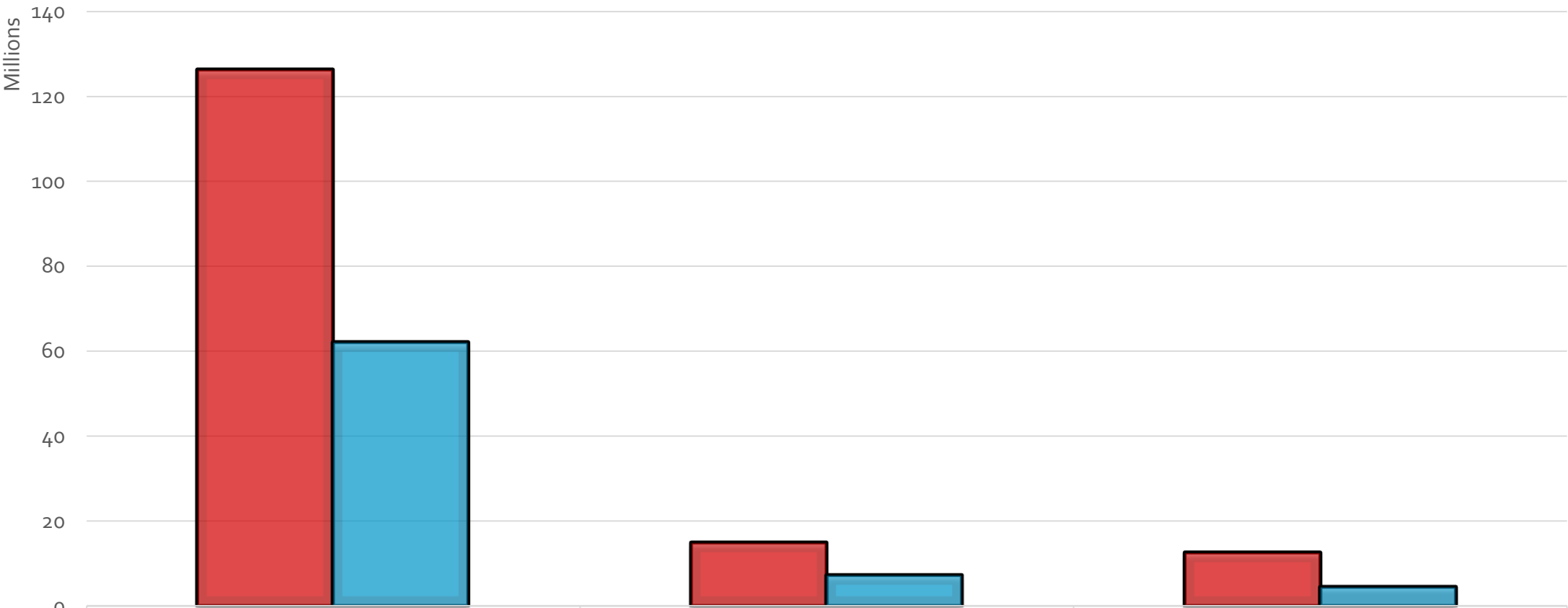

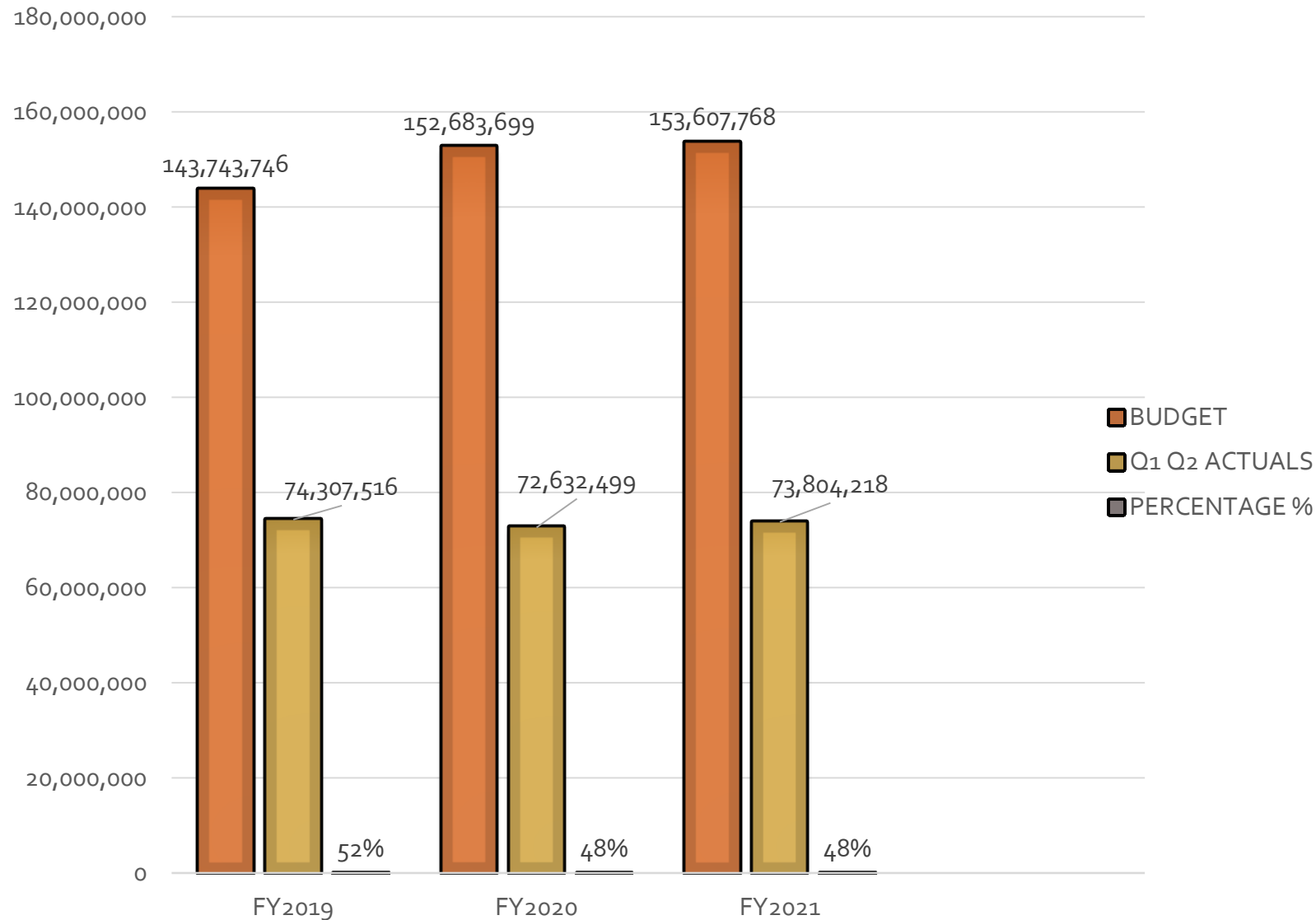

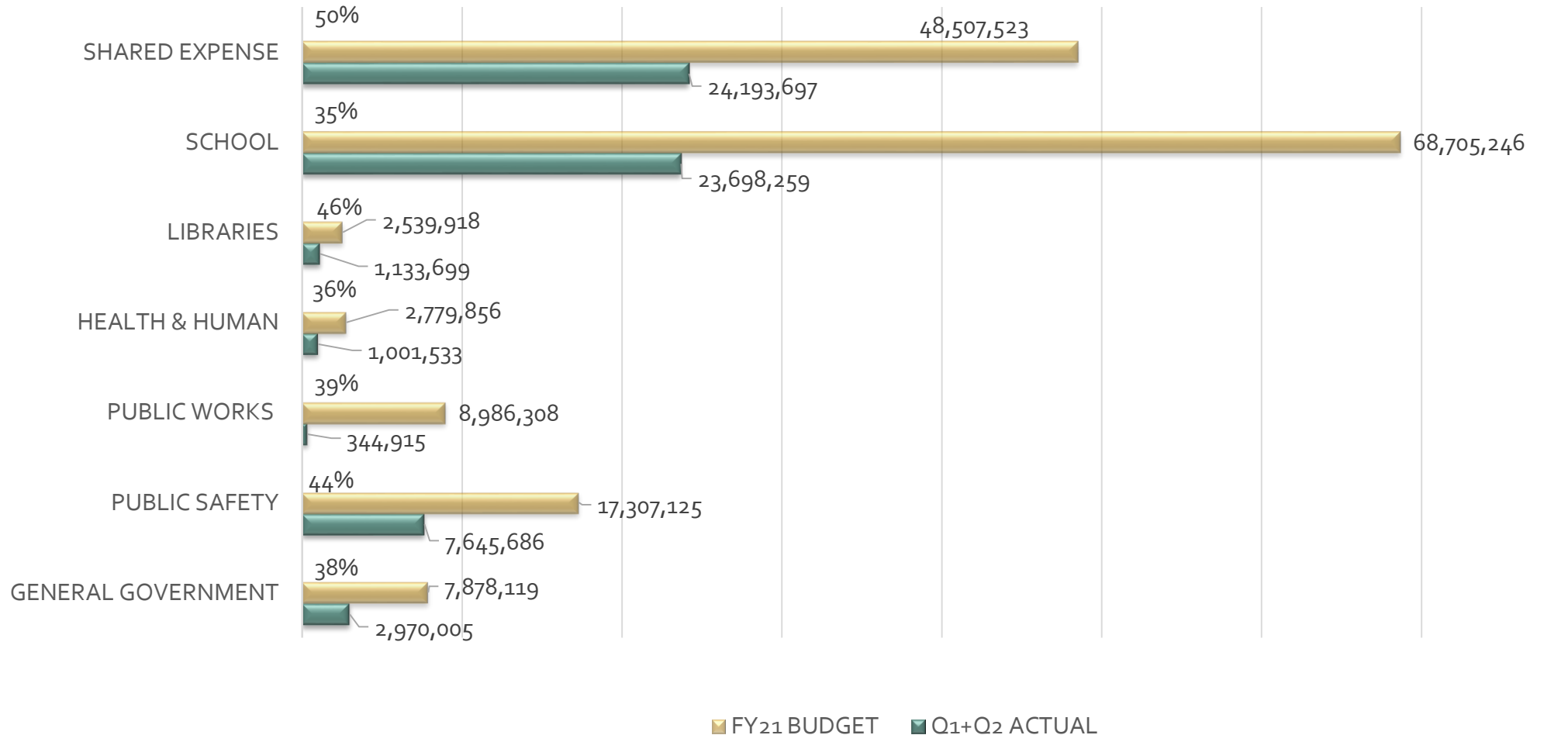

Historical Revenue Comparison FY19-FY21



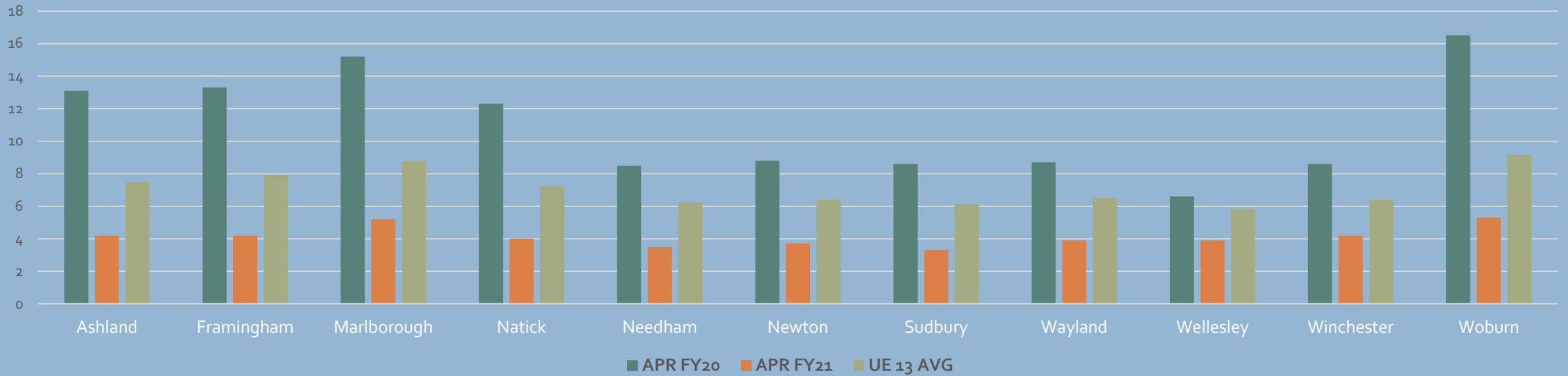
