The Meridian Lodge is planning to hold a Blood Drive on Saturday 22nd January 2022 in conjunction with the American Red Cross (ARC).

The Blood Drive will be held at the Lodge's building, 24 Main Street, Natick.

The timings are as follows:-

8:00 am to 9:00 am Setup

9:00 am to 2:00 pm Blood Drive

2:00 pm to 3:00 pm Dismantle

Members of the Lodge will actually arrive at around 7:30 am to open the building with the ARC personnel arriving soon afterwards.

The ARC truck will arrive around 8:00 am and leave in the region of 3:00 to 3:30 pm after everything has been dismantled by the ARC.

Please may I ask permission that the last 4 parking spaces between Fair and Yeager Insurance Agency, 10 Main Street, and Byrne Home Health Center, 16 Main Street, are set aside for the ARC to park their van for this blood drive from 7:30 am to 3:30 pm on Saturday 22nd January 2022?

In the past, we have been asked to supply the following documents:-

- 1. A certificate of liability insurance naming the Town of Natick as an additional insured.
- 2. A signed and notarized indemnification agreement.

If these are required, we will gladly supply them.
