Joan,

I have discussed this with Mr. Gusmini, the town's Building Commissioner and agreed that we would recommend that the Select Board approve this with the following conditions:

- 1. The scaffolding be protected with "scrim" so that falling debris does not hit pedestrians below;
- 2. The underside of the scaffolding be illuminated so as to allow for safe passage at night;
- 3. The scaffolding either be removed prior to embarking into the winter snow season;
- 4. All safety and/or advisory signage as directed by the Building Commissioner be placed so as to safely guide pedestrians.
- 5. Parking for construction vehicles be arranged off street in advance so that they do not interfere with customer parking for the local businesses.
