PUBLIC TESTIMONY & WARNINGS RE. Natick's Face Mask Mandate:

Natick's new Face Mask mandate harms human health and violates federal laws. There is no evidence supporting the use of face masks, and mandating masks is clearly illegal. Expecting a face mask to stop a virus is lil chain-link fence to stop mosquitos. A far more logical and common sense way to stop the spread of a viral respiratory illness is to educate people as to how to stop the replication of virus in nasal and oral cavities before it spr lungs or to other persons.

I. There is not one study that shows face masks have ever slowed the spread of a respiratory viral illness. I have read every face mask study posted on the CDC's website plus dozens of others. The only studies purporting to s facemasks slow the spread of a respiratory viral illness were scientifically invalid because the studies either:

- (1) did not examine the full range of the explanatory variable (only looked at states with face mask mandates and none without mandates); or
- (2) could not show any relationship between face masks, COVID cases, hospitalizations, or deaths until after applying model manipulation by adding additional unrelated variables in a regression until they could elicit statistical outcome;
- (1) ignored and failed to collect seasonality patterns of viral respiratory illnesses; or ignored collected variables that explained differences, e.g., household size.

II. There is no data showing face masks slow the spread of any viral respiratory illness.

III. There are numerous studies showing face masks cause oxygen depletion to the blood and brain, which is especially dangerous to children whose brains are still developing.

A group of parents in Gainesville, FL, concerned about potential harms from masks, submitted six face masks to a lab for analysis. The resulting report found that five masks were contaminated with bacteria, parasites, and fu three with dangerous pathogenic and pneumonia-causing bacteria. No viruses were detected on the masks, although the test is capable of detecting viruses. .The analysis detected the following 11 alarmingly dangerous patho masks:

- Streptococcus pneumoniae (pneumonia)
- Mycobacterium tuberculosis (tuberculosis)
- Neisseria meningitidis (meningitis, sepsis)
- Acanthamoeba polyphaga (keratitis and granulomatous amebic encephalitis)
- Acinetobacter baumannii (pneumonia, blood stream infections, meningitis, UTIs— resistant to antibiotics)
- Escherichia coli (food poisoning)
- Borrelia burgdorferi (causes Lyme disease)
- Corynebacterium diphtheriae (diphtheria)
- Legionella pneumophila (Legionnaires' disease)
- Staphylococcus pyogenes serotype M3 (severe infections—high morbidity rates)
- Staphylococcus aureus (meningitis, sepsis)

Half of the masks were contaminated with one or more strains of pneumonia-causing bacteria. One-third were contaminated with one or more strains of meningitis-causing bacteria. One-third were contaminated with dangerous resistant bacterial pathogens. In addition, less dangerous pathogens were identified, including pathogens that can cause fever, ulcers, acne, yeast infections, strep throat, periodontal disease, Rocky Mountain Spotted Fever, and The face masks studied were new or freshly-laundered before wearing and had been worn for 5 to 8 hours, most during in-person schooling by children aged 6 through 11. One was worn by an adult. A t-shirt worn by one of t school and unworn masks were tested as controls. No pathogens were found on the controls.

IV. There is no evidence of non-symptomatic children spreading Covid to each other, to their teachers, or to their elderly relatives.

V. It is a violation of federal law to mandate face masks or any EUA product.

FTC Act - Deceptive Medical Practices Clause. It is illegal to promote a product intended to diagnose, treat, cure a disease without at least 2 independent clinical trials which have shown the truth of the statement. CR Mac only clinical trial, placebo controlled, 3 yr study which showed that cloth face masks can cause influenza type symptoms. This led to the April 2020 JAMA publication that concluded that a healthy population should not wear It's illegal to practice medicine without a license and to violate the Deceptive Medical Practices. Face masks have never been shown to have a medical benefit; rather they've been shown to create problems. It's illegal to practice without a license. So any mandate or recommendation is a violation of the Medical Standards Act of every state, of the Deceptive Medical Practices Clause, and against medical advice (AMA). You cannot be a licensed medic and suggest therapy that's contraindicated to the thing you are promoting.

Under an [Emergency Use Authorization \(EUA\)](#) by the U.S. Food and Drug Administration (FDA) and FDA guidance states that recipients shall “have the option to accept or refuse the EUA product.” ’

“Federal law, [Title 21 U.S.C. § 360bbb-3\(e\)\(1\)\(A\)\(ii\)\(I-III\)](#) of the Federal Food, Drug, and Cosmetic Act, states the following about products granted emergency authorization usage:

Individuals to whom the product is administered are informed—

(I) that the Secretary has authorized the emergency use of the product;

(II) of the significant known and potential benefits and risks of such use, and of the extent to which such benefits and risks are unknown; and

(III) of the option to accept or refuse administration of the product, of the consequences, if any, of refusing administration of the product, and of the alternatives to the product that are available and of their benefits and risks.

Any entity or organization that requires EUA COVID-19 vaccinations, COVID-19 tests or masks are in violation of federal law, and will likely face lawsuits if they don't allow exemptions or alternatives.”
