Dear Select Board,

We are writing to you today to voice our concerns about the possibility of Fern Street not having a sidewalk along the entire length of the road. As you are aware, the Fiske Road neighborhood is densely populated. On any given day, at any given time, you will see people out walking their dogs, kids on bikes, and even high school teams training in our neighborhood.

Fern Street is one of the major thruways in the neighborhood. The street provides access to the ice rink, Dug Pond, and the high school. It has come to our attention that a sidewalk may not be put in on the section between Proctor and Moore during the construction schedule for this summer. We as a neighborhood would like to strongly voice our opinion that a sidewalk (even on just one side) along the entire length of Fern Street is needed.

The opportunity to include this public safety measure will not come around again anytime soon. We implore you to look at what is best for the entire neighborhood and the safety of all our children by including a sidewalk along the entire length of Fern Street. Please note, we do not wish the issue of a sidewalk to delay the project.
