Response	 Move that the Town vote to re-appropriate \$310,000 to be expended under the direction of Town Administration, which were originally appropriated from the Mathworks Mitigation Fund to be used for road improvement projects under Article 23 of the 2013 Spring Annual Town Meeting, which amount is no longer needed to complete the project for which it was originally appropriated, as follows: \$300,000 for the purpose of design and construction of improvements to the intersection of Walnut Street and Bacon Street \$10,000 for the purpose of design and construction of trailhead improvements at the Rt. 9 entrance to Hunnewell Town Forest
2	At a summary level and very clearly, what is the proposed purpose and objective of this Warrant Article and the accompanying Motion?
Response	To re-appropriate funding that was originally intended to support transportation oriented projects proximate/associated with the Mathworks Apple Hill expansion project, specifically targeting the Oak Street and Route 9 intersection project. That project was completed as planned, with these funds being unused and available for re-appropriation. The Town has several transportation oriented projects that provide additional opportunities for transportation mobility improvements proximate to the Apple Hill campus, including improving access to open space and intersection improvements as Walnut/Bacon Streets. The motion seeks to authorize Town Administration to appropriate the necessary funding and execute any/all instruments that may be necessary to affect said projects. These projects have all been vetted and supported by the Planning Board, the Conservation Commission, and MathWorks (see attached support letters).
