REQUEST FOR CHANGE IN SPECIAL COUNSEL

This memo is to request a change in special counsel to support the Assessors in matters before the Appellate Tax Board. The Appellate Tax Board (ATB) is the state court specifically setup to hear tax appeals, including those appeals originating at the local level through the abatement process.

The primary goal of this request is to protect the Assessors Overlay account. The Overlay account is setup specifically to fund property tax exemptions (low income/asset senior citizens, disabled veterans, blind individuals, etc.) along with abatements and unfavorable court judgements. In 2008, the Select Board appointed Attorney Kenneth Gurge to be our Special Counsel in these matters. Mr. Gurge is now semi-retired and I am looking to change counsel. We have been fortunate to not need legal services for the last couple of years and have handled most appeal work internally. However, our ATB docket has filled up in part due to the Covid-19 crisis that has had a negative effect on the value of certain classes of commercial, industrial, and personal property. The ATB is a specialized court and thus requires specialized expertise. Please note that this subject has been discussed with our Town Counsel, Karis North and she supports this request.

Included with this memo is a summary of the practice and experience of attorney James Sullivan, whom I ask you to vote to appoint as special counsel for ATB purposes. Mr. Sullivan is highly experienced and has represented many other communities in these matters. He also represents Framingham and thus brings experience in our particular real estate market.
