Yes. I figured I'd ask for what we need for our renter and if they say midnight that's what we will offer them. Here are a few





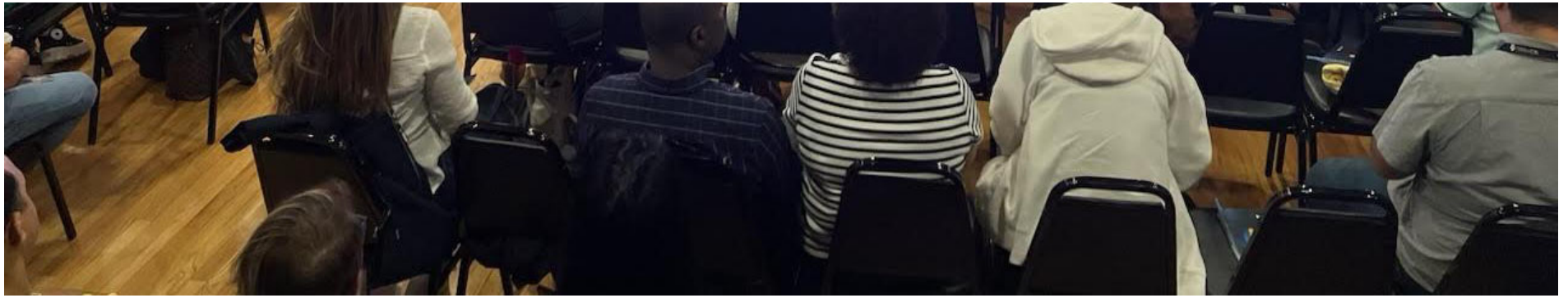
