Hi Joan,

I wanted to follow up with you about the Permit for the Wick Fun Run at Brown.

1. Event date: 10/31 (we are working on 9-11am)
2. Location: Brown Elementary School (1 Jean Burke)
3. The route is pictured below - From the school to Barnesdale to Surrey, Sherwood, Nottingham and Greenwood and back to the school.
4. We expect about 150-200 people to attend. We plan on having a DJ set up outside, a bake sale/school merchandise tables, refreshments for the runners, maybe pumpkin painting, a 2 mile run and a 50 meter and 100 meter dash around the school or along the grass/sidewalk at the entrance to the school.
5. Our Insurance is through Philadelphia Insurance Company - The policy number is EU 78861.
6. You asked for an Indemnity Agreement- could you email it to me and I will get it to you today?
