| 2 | At a summary level and very clearly, what is the proposed purpose and objective of this Warrant Article and the accompanying Motion? |
| Response | On May 23, 2022, Town Departments, which include Community and Economic Development (CED), Fire Department, and Licensing, launched ViewPoint, an online permitting program. All department applications can be submitted and processed electronically, eliminating the requirement for paper submittals. Currently, the Natick Zoning Bylaw references paper submittal and the number of paper copies required for an application. Article 23 removes reference to paper submittals and the number of paper documents to align with current electronic permitting. |

| Response | The use of electronic permitting is a new process for the Town, therefore, Article 23 modifies past practices of paper submittal. |

| Response | On May 23, 2022, Community and Economic Development, the Fire Department, and Licensing switched from a paper-based application process to an electronic online permitting process. The current Natick Zoning Bylaw outlined the process and number of paper documents required for submittal. Therefore, an application submitted electronically is no longer in compliance with the Natick Zoning Bylaw, requiring an applicant to request waivers for compliance with the Town's new permitting practices. |

| Response | In 2018, Town Meeting adopted a non-binding resolution to achieve net zero emissions by 2050. Article 23 is aligned with this effort by reducing paper submittal of applications and supporting documents, reducing the number of vehicular trips to transport paper applications and supporting documents, and reducing the amount of physical space for storing applications and supporting documents. Furthermore, reducing the waste produced when applications and supporting documents can be disposed of according to the Commonwealth's record retention laws. |
