Attached is some info on what we are looking at for Natick based on our experiences in Hopkinton. Our theme will be "Celebrating Patriotism on Patriots' Day".

The tent is 20'x32' but its footprint is a little bigger based on the tie downs. As we mentioned, it will need to be staked or weighted down for safety and stability.

Besides the historical uniform display, we would also have a display featuring a personnel parachute and reserve parachute, and helmets and body armor for adults and kids to try on, as well as a display of combat rations (MREs and others).

Please let me know what questions I can answer for you ahead of the Board meeting.
