<b>Position Title:</b>	Traffic Constable	PT Grade Level:	Premium

<u>Statement of Duties</u>: The primary duties are to provide traffic control at locations that cannot be covered by Sworn-Officers. The major responsibilities of this position require consistent attention and commitment to this agency's mission. All assigned duties and tasks are expected to be performed in an effective, efficient and safe manner. The Traffic Constable must accept the responsibility to support and promote the mission of the Natick Police Department and comply with its directives.

<u>Supervision Required:</u> The employee performs work duties under the general and broad supervision of a designated officer of the department and individual supervisor of the shift.

**Supervisory Responsibility:** None

**Accountability:** Failure to perform duties can result in public safety issues as it relates to managing traffic flow.

<u>Judgment:</u> Choosing the appropriate practices, procedures, or regulations on traffic management to apply in each case.

<u>Complexity:</u> The management of traffic flow is itself complex. Conditions are dependent on structure of worksite as it relates to driver actions and reactions to detours, slowdowns or diversion. Must be able to consider all factors when directing the flow of traffic around a construction site while also managing the work crew attempting to complete a task.

**Work Environment:** Work is performed out-of-doors during all types of weather and there is a lot of standing. There are dangers in this work, such as: motor vehicles, construction equipment and pedestrian traffic and acts of irritate citizens. Safety precautions must be taken at all times.

**Occupational Risks:** Work in an active traffic work zone is inherently risky.

### **Essential Functions:**

- Must be at least 18 years old.
- Must be physically and mentally capable of performing the duties of the position.
- Must pass a detailed background check.
- Must not have extensive or serious criminal convictions.

- Able to read, write, speak and understand the English language.
