Dear Mr. Corcell,

As I wrote to you previously, there are no rules for the Board engaging with the public and taking public comment. A practice is to allow all who wish to speak on a particular topic the opportunity to speak, especially with issues that garner great public attention. Another practice is to limit the public comment to 3 minutes or less, especially when there are many people who wish to speak. Another practice is to not allow the public to address an issue, unless the matter is being heard in a Public Hearing, which requires the Board accept public comment under law. Another practice is to read all of the emails received into the public record.

I will re-state this for you: Generally, when there are speakers on Zoom and in the room who wish to speak, the Chair (at his or her discretion) calls on someone in the room first, then Zoom, and back again until everyone has had a chance to speak.

You seem to be extraordinarily "disgusted" (a word you used in a couple of previous emails) that Ms. Ball, a former resident of 67 years, was permitted to speak. I will not address this issue again. In my previous response, I did not copy "selectboard@natickma.org" because all of those emails are posted on-line for everyone to read.

I have copied selectboard@natickma.org so that this email, and my response, are posted for public view.

Dear Mr. Corcell,

Thank you for your question. I do not have a conflict of interest in working on or presenting the proposed policy to the Board. I have never "worked on policies on immigration" as you state. I have, however, worked with non-profits that worked with the State Department in public diplomacy overseas. I have consulted pro bono (for free) with non-profits, educational institutions, and with US-based and foreign-based immigration attorneys on social and cultural issues in the Muslim world.

The work I did with immigration attorneys mostly involved individuals who were seeking asylum because of human rights issues in their home countries. If a man were gay and lived in Iran, he credibly faces persecution and perhaps death. If a woman in Egypt is the victim of domestic abuse and rape by her husband, she may qualify for asylum in the United States. I am/was an expert in Islamic law as it pertains to marriage and divorce and I simply referred attorneys who sought help for their clients to experts who could testify in court. None of these clients were in Natick--most were in Washington, DC and Boston.

I hope this clears up any misunderstandings you have about my background.

Mr. Corcell,

I cannot speak to why other towns and cities do or don't do anything. I can speak to the public policy reasons that the proposed policy was crafted:

- ensure public safety of Natick residents, staff and businesses;
- establish guidelines for the use of finite Town resources;
- shield our police personnel from liabilities resulting from enforcement of federal civil immigration laws; and,
- reiterate that town employees are obligated to follow state and federal law (including case law) regarding the subject of immigration.

For the first reason, ensuring that the immigrant community knows that if they are the victims of or witnesses to a crime, they can come forward to work with law enforcement without fear that they, or their loved ones, or their neighbors won't be subject to retribution. Most people (including taxpayers, life-long residents, native-born Americans) do not know that the Natick Police Department **must** abide by the Commonwealth's law and **not enforce civil federal immigration laws.** 

The policy reinforces that the town will not use its finite taxpayers dollars doing the federal government's work. The policy shields Natick police from liabilities that result from enforcing federal civil immigration policies (paying money out in lawsuits).

Some adopt similar policies and name them differently. There is no single legal definition of what a sanctuary city is--every policy, bylaw or city ordinance is different.

There are no financial incentives to towns or cities that adopt a policy such as is proposed. There are no federal or state funds that support those communities. In Massachusetts, **all** cities and towns are required to comply with the Commonwealth's law as stated in Lunn v. Commonwealth that **prohibits** all law enforcement (including Natick's) from detaining or arresting an individual for a civil federal violation.
